## Agreement for Use of Polly's Chapel

I / we enter into agreement with Polly Texas Pioneer Association for use of Polly's Chapel under the following conditions:

- The capacity of the Chapel and grounds is 100 persons.
- Smoking is not permitted inside the Chapel.
- The use of tacks, nails, staples, or adhesives of any kind is not permitted on or in the Chapel.
- The person signing this agreement would be liable for any damage incurred.
- Excessive use of electrical devices such as amplifiers, electronic motors, etc. is not permitted.
- The Chapel, pavilion, rest rooms and grounds must be left clean with lights turned off and all doors and windows must be closed prior to leaving the Chapel.
- Trash is to be placed in trash bags and carried off the premises.
- Parking is allowed only in designated areas.
- No trees or shrubs are to be cut for any purposes.
- The pews, cushions, and any other furniture in the interior of the Chapel are not to be removed.
- No BBQ pits or Fire pits on premises.
- No fireworks
- No Alcohol
- Please observe a standard code of behavior, ethics, and reverence while in and on grounds of this historical Methodist church.

### Fee Schedule for Chapel

- Chapel and pavilion rental 8 am – 1 pm or 3 pm – 8 pm \$750
- Photo Shoot 2 hours \$150

To reserve a date for a chapel rental, a 50% deposit must be made. The balance must be paid 30 days before the event. Deposits are non-refundable.
